Freeport Minerals Corporation, Copper Queen Branch (CQB) is submitting the twenty-sixth Status Report in accordance with Section V.A. of Mitigation Order on Consent No. P-121-07. This submittal covers the period from September 1, 2014 through November 30, 2014 in accordance with ADEQ's February 12, 2008 approval of the schedule for submission of quarterly Status Reports.

Since September 1, 2014, the following measures have been taken under Section III of the MO:

- Submitted Third Quarter 2014, Mitigation Order Status Report dated September 2, 2014.
- Submitted Third Quarter 2014, quarterly groundwater monitoring report dated October 22, 2014.
- Completed fourth quarter 2014 groundwater monitoring except for a few samples which will be collected in December.
- Commenced the drilling program for the expanded groundwater monitoring program at Turquoise Valley Golf Club.
- The third Community Advisory Group (CAG) of 2014 was held on September 24, 2014. The Freeport Information Open House will be held December 12, 2014, which will fulfill the requirements of the fourth CAG meeting of 2014.

During the next quarter, the following activities will be conducted:

- Submit fourth quarter 2014 groundwater monitoring report.
- Begin first quarter 2015 groundwater monitoring.
- Continue drilling and construction of monitoring wells for the expanded groundwater monitoring program.
- Begin bid selection process for alternative water supply test wells.
- Hold first CAG meeting for 2015.
